Present: President Sheila P, VP Steve C via phone, Treasurer Paul C, Secretary Kathy W, and At Large Jason G via phone

Minutes read and approved as follows: Motion Paul C to approve minutes from 11/09/2016 as presented and read, 2nd Steve C, all in favor/unanimous. Motion Paul C to approve minutes from 11/11/2016 as presented and read, 2nd Steve C, all in favor/unanimous.

Special reports of Board members and other board sanctioned committees:

President Sheila P presented the official fining committee. Committee consists of Georgie of lot 30, Frank of lot 39 and John of lot 20. Paul made a motion to accept the fining committee as named. Kathy W 2nd, all in favor/unanimous.

President Sheila P presented the official declaration of condominium & by-laws committee to work on areas that need possible updating. Committee consists of Jacquie of lot 46, Nancy of lot 34 and Barry of lot 36. Paul made a motion to accept the declaration of condominium & by-laws committee as named. Steve C 2nd, all in favor/unanimous.

President Sheila P announced that Vanguard will be taking over enforcement of our Declaration of Condominium section 12.14 (nudism) by February 7th. This section states in part: **All owners must be members of a AANR or other recognized nudist organization and practice social nudism.** This regulation cannot be changed except by a vote of eighty (80%) of the voting membership of the Association.

Fred N. presented a proposal to gate or enclose dumpster area. Sheila P. to get a bid from Family Fence.
